


Optional farm & ranch coverages

Additional farm insurance coverages

Various endorsements to your farm or ranch insurance policy can be used to customize coverage to the unique needs of your operation.

Disruption of farming operations

Covers extra expenses and loss of income caused by a covered loss to a building.

Identity fraud expense coverage

Reimburses you for up to \$25,000 to restore your identity.

Earthquake coverage

Covers earthquake damage to a farm or ranch near a fault line.

Farm machinery and equipment replacement cost

Replaces equipment up to five years old during a covered loss.

Peak season coverage endorsement
